OF NOTICE OF BREACH AND ELECTION TO SELL UNDER DEED OF TRUST

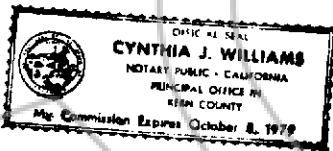
WHEREAS, in the matter of the Deed of Trust executed by EDWARDS R. HOPPLE and
