 which is hereby acknowledged, and pursuant to our option  
 agreement dated September 7, 1973, and an addendum thereon  
 dated August 29, 1974 entered into between the parties hereto,

 and sold and by these presents does hereby grant and convey to  
 the party of the second part, its successors and assigns, all  
 of his right, title and interest in and to certain personal  
 property known as the "South Mill Tailings Ponds", being ponds  
 numbered one through five, adjacent to the Casleton Mill, in  
 Section 12, Township 1 North, Range 67 East, M.D.B. & N.,  
 Lincoln County, Nevada, subject to the retention and reserva-  
 tion by the party of the first part of two percent of the  
 net smelter returns required by the party of the second part  
 from the sale and disposition of the mineral tailings and  
 the mineral values contained therein as set forth in para-  
 graph 1 of said addendum.
