## TREASURER'S RECONVEYANCE DEED

A reconveyance shall not be made after expiration of the 90 day period specified in N.R.S. 361.603 or after commencement of posting or publication of public notice pursuant to N.R.S. 361.595.", and

WHEREAS, the said Fred H. and Thelma Mable Laird, the Grantee herein, has tendered to the County Treasurer the proper amount of money as is required in such cases and no public notice of sale having been given by the County Treasurer.
