CERTIFICATE OF LOCATION OF LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has located the
Last Chance Lode Mining Claim in the SW $\frac{1}{4}$ / NW $\frac{1}{4}$
of Sec. 9 / 16, T. 9 N., R. 64 E., M.D.B. & M. in the
Patterson Mining District, in Lincoln
County, State of Nevada, on the 12th day of January, 1978.

And further certifies that the above named claim was located

The claim is 1500 feet long and 600 feet wide, and
1480 feet is claimed in a Northeasterly direction and 20
feet in a Southwesterly direction from the discovery monument, at
which the Notice of Location is posted, lengthwise of the claim,
together with 300 feet in width on each side of the center of
the claim. The general course of the lode deposit and premises
is from the Southwest to the Northeast.

The location of each corner of this claim is shown on the
claim map that is filed herewith. On the ground, each corner of
the claim is marked with its appropriate location by an inscription
on each post.

At all corners, side centers and discovery monuments are
4"x 4"x 4 $\frac{1}{2}$ ' long wooden posts.

The monumentation and marking of the corners was completed
by the 20th day of January, 1978.

The location work consisted of making a claim map as pro-
vided in NRS 517.040. Two copies of this claim map have been
filed with the Lincoln County Recorder, and the \$15.00
lode claim filing fee has been paid to the County Recorder.
