- 4. That Plaintiffs be, and they are hereby, found, determined and declared to be the lawful owners of an appurtenant easement for access purposes over a strip of land described as follows:

five (25) and said West half of Lot Twenty-four (24) and having thereon a driveway of compacted earth which connects on the East side with Plaintiffs' property below described and connects on the West side with High Street, a public street, and which drive-way is bounded on the North side by retaining wall of concrete which separates said drive-way from High Street below and which drive-way is bounded on the South side by a concrete retaining wall which separates said drive-way from the yard of Defendants some five feet (5') above.

5. That Plaintiffs title to said easement be, and it is hereby, quieted against all claims, demands, or pretentions of Defendants, their heirs, assigns or successors in interest.

6. That Defendants, their heirs, assigns and successor in interest be, and they are hereby, perpetually restrained and enjoined from interfering in any manner with the use of said easement by Plaintiffs, their heirs, assigns and successors in interest, and their agents, servants, and invitees as a means of ingress to and egress from that certain real property situated and lying in the County of Lincoln, State of Nevada, more particularly described as follows:

All of Lots numbered Twenty-three (23) and Seventy (70); the East one-half of Lots numbered Twenty-four (24) and Sixty-nine (69) and the West one-half of Lots numbered Twenty-two (22) and Seventy-one (71) all in Block numbered Twenty-three (23) in the town of Pioche, Lincoln County, Nevada, as said lots and block are platted and described on the official plat of said town of Pioche, now on file and of record in the Office of the County Recorder of said Lincoln County, Nevada, and to plat and the records thereof reference is hereby made for further particular description. Together with any and all buildings and improvements situate thereon.

7. That Plaintiffs, their heirs, assigns and successors in interest be, and they are hereby, perpetually restrained and enjoined from parking upon the property of the Defendants, which property is subject to the above described easement, and they are further perpetually restrained and enjoined from permitting their guests to park thereon.

8. That neither Plaintiffs nor Defendants recover costs or attorney fees herein.
