AMENDED CERTIFICATE OF LOCATION
(Lode Mining Claim)

Lime Cap No. 3 Lode Mining Claim

This is to certify that the undersigned Locator did on the 26th day of September, 1978, amend, locate and claim, and does hereby amend, locate and claim, by right of discovery and location and this Amended Certificate of Location, and in compliance with the Mining Laws of the United States and the State of Nevada, and the local customs and rules of the district in which the claim is located, a lode mining claim called Lime Cap No. 3.

The date of original location of this claim was July 25, 1942. The original Certificate of Location was recorded January 11, 1943 in Book N-1, Pages 211-212, Official Records, in the Office of the Recorder of Lincoln County, Nevada. The location work consisted of the preparation and filing of mining claim maps and payment of fees prescribed by Nevada law.

The general course of the lode or vein of this amended location is:

Southwesterly and northeasterly. The Locator claims 1500 feet along the course of the vein, with all its dips, spurs, angles and variations as allowed by law, 32 feet along said vein running N81°-53'-25" E. from the center of the discovery monument and 1,468 feet along said vein running S81°-53'-25" W. from the center of the discovery monument together with 300 feet on each side of the center of said vein at the surface, and all veins, lodes, ledges and deposits and surface ground within the lines of said claim, situated in the Tempiute Mining District, Lincoln County, Nevada, and described by metes and bounds as follows:

Beginning at Corner No. 1 (the Northeast Corner);
Thence S8°-06'-35"E, 600 feet to Corner No. 2 (SE);
Thence S81°-53'-25"W, 750 feet to the South Side Center;
Thence S81°-53'-25"W, 750 feet to Corner No. 3 (SW);
Thence N8°-06'-35"W, 600 feet to Corner No. 4 (NW);
Thence N81°-53'-25"E, 750 feet to the North Side Center;
Thence N81°-53'-25"E, 750 feet to Corner No. 1 (NE), the place of beginning. From Corner No. 1 (NE) U.S.M.M. No. 326 bears N7°-05'-37"W, 3,661.43 feet. The claim is situated within the SW $\frac{1}{4}$ of Section 31, T.3 S, R. 57 E., M.D.M.

This Amended Certificate of Location is made without waiver of any previously acquired rights. It is made for the purpose of correctly describing the position of the discovery monument. This Certificate is intended as an Amended Certificate of Location. It also may be considered as the certificate of an original location made on the 26th day of September, 1978, and based on a discovery made within the claim on said date, if required by law.
