RUBY LISTER, COUNTY TREASURER OF LINCOLN COUNTY, NEVADA, AS TRUSTEE, "FIRST PARTY"

WITNESSETH: That the said First Party in consideration of the sum of: Three Thousand One Hundred Nine Dollars and No Cents, lawful money of the United States of America, and in consideration of the full compliance with the Statutes of the State of Nevada, hereto appertaining, said lawful money to First Party in hand paid by said Second Party, the receipt whereof is hereby acknowledged, does by these presents, GRANT, BARGAIN, and SELL unto the Second Party all the right, title and interest of the County of Lincoln, State of Nevada, in and to the following described property:

TOGETHER, WITH the tenements, hereditaments and appurtenances thereunto belonging or appertaining, the reversions, remainders, rents, issues and profits thereof.

TO HAVE AND HOLD the said premises, together with the appurtenances unto the Second Party and to their heirs and assigns forever
