RUBY LISTER, COUNTY TREASURER OF LINCOLN COUNTY, NEVADA, AS TRUSTEE, "FIRST PARTY"

To

Edward Weinstein

WHEREAS, the property hereinafter described was heretofore duly assessed for tax purposes and taxes were paid thereon until the tax year 1970-1971, for which said year taxes were not paid and were marked "Delinquent" all pursuant to law, and,

WHEREAS, the requirements of law regarding delinquent taxes were fulfilled by the County Treasurer of Lincoln County, Nevada, and in due time said property was conveyed to the said Treasurer as Trustee for the said County and State, and,

WHEREAS, the Board of County Commissioners of Lincoln County, Nevada on the 20th day of July, 1978, ordered said property advertised and sold in the manner prescribed by law and that Edward Weinstein, hereinafter named, having submitted the highest bid at public auction and all requirements of law, having been fulfilled.

NOW, THEREFORE, THIS INDENTURE, made this 25th day of September, A.D., 1978, by and between RUBY LISTER, County Treasurer of Lincoln County, Nevada, as Trustee, hereinafter referred to as "First Party", and Edward Weinstein, of 2305 Las Vegas Blvd. South Las Vegas, Nevada 89104 hereinafter referred to as the Second Party.


WITNESSETH: That the said First Party in consideration of the sum of Three Thousand One Hundred Nine Dollars and No Cents, lawful money of the United States of America, and in consideration of the full compliance with the Statutes of the State of Nevada, hereto appertaining, said lawful money to First Party in hand paid by said Second Party, the receipt whereof is hereby acknowledged, does by these presents, GRANT, BARGAIN AND SELL unto the Second Party all the right, title and interest of the County of Lincoln, State of Nevada, in and to the following described property:

S&N\W&NE Section 31, Township 6 South, Range 61 East excepting a 100 Foot access easement along the Easternmost portion

TOGETHER, WITH the tenements, hereditaments and appurtenances thereunto belonging or appertaining, and the reversions, remainders, rents, issues and profits thereof.

TO HAVE AND HOLD the said premises, together with the appurtenances unto the Second Party and to their heirs and assigns forever.
