RUBY LISTER, COUNTY TREASURER OF LINCOLN COUNTY, NEVADA, AS TRUSTEE, "FIRST PARTY"

To

Delores Budreau

WHEREAS, the property hereinafter described was heretofore duly assessed for tax purposes and taxes were paid thereon until the tax year , for which said year taxes were not paid and were marked "Delinquent" all pursuant to law, and,

WHEREAS, the requirements of law regarding delinquent taxes were fulfilled by the County Treasurer of Lincoln County, Nevada, and in due time said property was conveyed to the said Treasurer, as Trustee for the said County and State, and,

WHEREAS, the Board of County Commissioners of Lincoln County, Nevada on the 30th day of July, 1978, ordered said property advertised and sold in the manner prescribed by law and that Delores Budreau hereinafter named, having submitted the highest bid at public auction and all requirements of law, having been fulfilled.

NOW, THEREFORE, THIS INSTRUMENT, made this 25th day of September, A.D., 1978, by and between RUBY LISTER, County Treasurer of Lincoln County, Nevada, as Trustee, hereinafter referred to as "First Party" and Delores Budreau of Caliente, Nevada 89008 hereinafter referred to as "Second Party."



All of that portion of Lot 3 Section 4 Township 5 South, Range 70 East lying South of the Southern boundary of the Railroad right-of-way.

TOGETHER, WITH the tenements, hereditaments and appurtenances thereunto belonging or appertaining, and the reversions, remainders, rents, issues and profits thereof.

TO HAVE AND HOLD the said premises, together with the appurtenances unto the Second Party and to their heirs and assigns forever.
