NOTICE IS HEREBY GIVEN that the OLD TIMER BLUE NOSE NO. 6

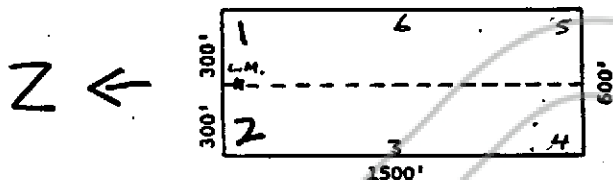
lode mining claim is hereby amended as the BLUE NOSE #18 lode
mining claim. This claim was located by LEO O. HOLT, MONA HOLT

on the 14th day of DECEMBER, 1963, and a copy of the location certi-
ficate is of record in the office of the Recorder of Lincoln County, Nevada in Book
V-1 page 352. This claim was previously amended as the BLUE NOSE #18
lode mining claim on the 1 day of OCTOBER, 1970, and a copy of the
amended location certificate is of record in the office of the Recorder of Lincoln
County, Nevada in Book 1 page 438.

The general course of this claim is NORTHERLY
This claim is 1500 feet in length along the course of the claim, being 50
feet from the point of discovery in a NORTHERLY direction to the
North end line of this claim, and 1,450 feet in a SOUTHERLY
direction to the South end line of the claim. This claim is 600 feet in
width, being 300 feet in width on each side of the center line of the claim.

This claim is located within the UNSURVEYED NE 1/4 quarter of
Section 24, Township R 8 S, Range G 6 E, Mount Diablo
Base and Meridian, Viola Mining District, Lincoln
County, Nevada. The location monument of this claim is situated with reference to
some natural object or permanent monument as follows: Approximately 3,990 feet in an
approximate N 11° 00' W. direction from the established common corner of sections 24 & 25
T. 8 S., R. 6 E. and sections 19 & 30 of T. 8 S., R. 6 E.

The corners of this claim are POSTS marked with the appropriate
corner number as shown on the following sketch and the accompanying claim map.



The location work consisted of making the maps as provided in NRS 517.040.

correcting any errors, defects or omissions in the original and amended location
