mining claim. This claim was located by

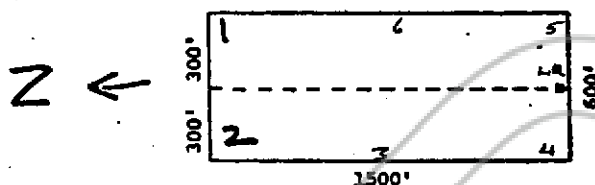

V-1 page 350. This claim was previously amended as the BLUE NOSE #22  
lode mining claim on the 1 day of OCTOBER, 1970 and a copy of the  
amended location certificate is of record in the office of the Recorder of Lincoln  
County, Nevada in Book 1 page 442.

The general course of this claim is NORTHERLY  
This claim is 1500 feet in length along the course of the claim, being 50  
feet from the point of discovery in a SOUTHERLY direction to the  
SOUTH end line of this claim, and 1,450 feet in a NORTHERLY  
direction to the NORTH end line of the claim. This claim is 600 feet in  
width, being 300 feet in width on each side of the center line of the claim.

This claim is located within the UNSUBVEYED SE 1/4 ~~part~~ of  
Section 19, Township W10N 8S, Range 69E, Mount Diablo  
Base and Meridian, V114P Mining District, Lincoln  
County, Nevada. The location monument of this claim is situated with reference to  
some natural object or permanent monument as follows: Approximately 3,400 feet in an  
approximate N76°15' E. direction from the established corner corner of sections 24 + 25  
of T. 8S, R. 68E and sections 19 + 30 of T. 8S R. 69E

The corners of this claim are POSTS marked with the appropriate  
corner number as shown on the following sketch and the accompanying claim map.
