lode mining claim is hereby amended as the BLUE NOSE #31 lode mining claim. This claim was located by

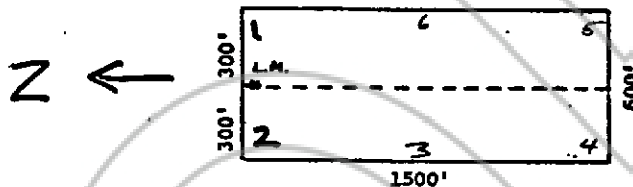
AET SCHMUTZ, GARY LEVITT

on the 14 day of MAY, 1964, and a copy of the location certificate is of record in the office of the Recorder of Lincoln County, Nevada in Book V-1 page 427. This claim was previously amended as the BLUE NOSE #31 lode mining claim on the 1 day of OCTOBER, 1970, and a copy of the amended location certificate is of record in the office of the Recorder of Lincoln County, Nevada in Book 1 page 451.

The general course of this claim is NORTHERLY. This claim is 1500 feet in length along the course of the claim, being 50 feet from the point of discovery in a NORTHERLY direction to the NORTH end line of this claim, and 1,450 feet in a SOUTHERLY direction to the SOUTH end line of the claim. This claim is 600 feet in width, being 300 feet in width on each side of the center line of the claim.

This claim is located within the UNSURVEYED SW/4 Section 30, Township VIOLET AS, Range 69E, Mount Diablo Base and Meridian, VIOLET Mining District, Lincoln County, Nevada. The location monument of this claim is situated with reference to some natural object or permanent monument as follows: Approximately 3,050 feet in an approximate S16°15'E. direction from the established corner of Sections 24 & 25 of T 23, R 68E and Sections 19 & 30 of T 23, R 69E.

The corners of this claim are POSTS marked with the appropriate corner number as shown on the following sketch and the accompanying claim map.



The location work consisted of making the maps as provided in NRS 517.040.

This amendment is made for the purposes of changing the name of the claim; correcting any errors, defects or omissions in the original and amended location certificates; complying with any requirements of the law that were not complied with prior to filing the original and amended location certificates; acquiring additional rights, if any, within the boundaries of this claim in compliance with the laws of the United States and the State of Nevada; all without waiver of any rights acquired within the above-described boundaries under the original location or any prior amendment thereof.
