WITNESSETH, that the party of the first part, in consideration of Ten Dollars and other valuable consideration paid by the party of the second part, does hereby grant and release unto the party of the second part, the heirs or successors and assigns of the party of the second part forever, unpatented mining claims

ALL that certain plot, piece or parcel of land, with the buildings and improvements thereon erected, situated, lying and being in the and located at WDC #36 Lode Mining Claim in Section 7, Township 6S, Range 65E in the Delamar Mining District, in Lincoln County in the State of Nevada.

TOGETHER WITH all and singular the mines, minerals, lodes and veins, within the lines of said claims, and their dips and spurs and all dumps, rights, privileges and appurtenances thereunto in anywise belonging.

ALL in Section 7, Township 6S, Range 65E, Delamar Mining District, Lincoln County, Nevada.

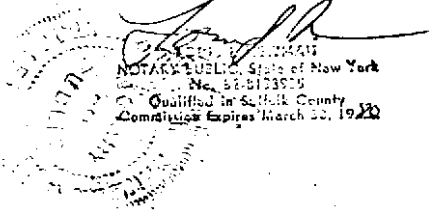
