DEED

THIS INDENTURE, made this 30 day of January, 1979,  
between NEVADA NATIONAL BANK, a Nevada Banking Corporation, Trustee,  
hereinafter called GRANTOR, and the STATE OF NEVADA, hereinafter called  
GRANTEE,

WITNESSETH:

That the GRANTOR, for and in consideration of the sum of TEN  
DOLLARS (\$10.00), lawful money of the United States of America, and  
other good and valuable consideration, the receipt whereof is hereby  
acknowledged, does by these presents grant, bargain, sell and convey  
unto the GRANTEE, and to its successors or assigns forever, all that  
certain tract, piece or parcel of land situate in Lincoln County,  
Nevada, more particularly described as follows:

That certain parcel of land known as the Strutzenegger calf  
pasture lying and being in the SW corner of and being a  
portion of the SW 1/4 of the SE 1/4 of Sec. 7, Township 2 North,  
Range 70 East, M.D.B. & M., and being on the west side of the  
main county road, traversed by a natural water course of what  
is known as Calf Pasture Springs and being bounded on 2 sides  
by rock ledges and fenced on the Northeasterly side and which  
borders the present county road and contains approximately  
3 acres, this being the same property conveyed to Samuel A.  
Hollinger by Rufus E. Hurst by Bargain and Sale Deed dated  
June 21, 1941, and recorded in Book F-1 of Real Estate Deed  
at page 117, Lincoln County, Nevada, Records.

INCLUDING any and all water and water rights belonging to,  
appurtenant, or in any way appertaining to said property.

TOGETHER WITH, all and singular, the tenements, hereditaments,  
and appurtenances thereunto belonging or appertaining and the  
reversion and reversions, remainder and remainders, rents, issues  
and profits thereof.

TO HAVE AND TO HOLD, all and singular, the premises together with  
the appurtenances, unto the said GRANTEE and to its assigns, forever.

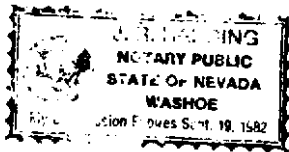
