This release and reconveyance relates to the real property described in the preceding paragraph and none other.

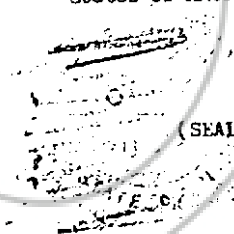
