

### Certificate of Location of Lode Mining Claim

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that Noranda Exploration Inc. has located the COT # 18 Lode Mining Claim in the <sup>SE</sup>SW  $\frac{1}{4}$  of Section <sup>30</sup>~~29~~ T 2N, R 71E in the State Line Mining District, in Lincoln County, in the State of Nevada, on the 18 day of March, 1979.

The claim is 1450 feet long and 550 feet wide, and 725 feet is claimed in a North direction and 725 feet in a South direction from the location monument, at which the Notice of Location is posted lengthwise of the claim, together with 275 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the East to the West.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked on the 4" diameter white plastic pipe or blazed tree as required.

The description of each corner is as follows:

Corner No. 1, the N.E. corner, is a 4" diameter white plastic pipe or blazed tree from which the N.E. corner of Section 17, T. 2N N., R. 71 E., M.D.B.E.M., bears North 13,100 Feet, and East 3300 Feet.

Corner No. 2 is a 4" diameter white plastic pipe or blazed tree.

Corner No. 3 is a 4" diameter white plastic pipe or blazed tree.

Corner No. 4 is a 4" diameter white plastic pipe or blazed tree.

Corner No. 5 is a 4" diameter white plastic pipe or blazed tree.

Corner No. 6 is a 4" diameter white plastic pipe or blazed tree.

The monumentation and marking of the corners was completed by the 20th day of March, 1979.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
