lawful money of the United States of America to him in hand paid by the said parties of the second part, the receipt whereof is hereby acknowledged, do es by these presents grant, bargain, and sell unto the said parties of the second part, in joint tenancy and to the survivor of them, and to the heirs and assigns of such survivor forever, all th at

certain lot, piece or parcel of land situate in Panamint Valley County of Lincoln State of Nevada

and bounded and described as follows, to wit:

The North 1/4 of the North 1/4 of the Northwest 1/4 of the Northeast 1/4 of Section 31, Township 6 South, Range 41 East, containing 10 acres.

More particularly described as follows:

Commencing at the NE corner of the NW 1/4 of the NE 1/4 of Section 31: running thence Southerly a distance of 330 ft.; thence Westerly a distance of 1320 ft.; thence Northerly a distance of 330 ft.; thence Easterly a distance of 1320 ft. to the point of beginning; excepting a 100 foot access easement along the easternmost portion.

Together with the tenements, hereditaments, and appurtenances therunto belonging or appertaining, and the reversion and reversions, remainder and remainders, rents, issues, and profits thereof.

To Have and to Hold the said premises, together with the appurtenances, unto the said parties of the second part, as joint tenants, and not as tenants in common, with right of survivorship, and to the heirs and assigns of such survivor forever.
