3 THOMAS L. CLAY, also known as THOS. L. CLAY, and also known
4 as TOM CLAY, residing at the 1001 Ranch, Caliente, County of Lincoln
5 State of Nevada, being first duly sworn upon oath deposes and says;

6 That Affiant presently is and at all times material hereto
7 has been the President and Corporate Owner of that certain Nevada
8 corporation known and designated as the PIOCHE RECORD PUBLISHING
9 COMPANY, INC., whose address and principle office are located
10 at the 1001 Ranch, Caliente, County of Lincoln, State of Nevada;

11 That Affiant is the Resident Agent for said corporation;
12 That said corporation has been doing business as the LINCOLN
13 COUNTY RECORD, a weekly newspaper publication of the state of
14 Nevada at the aforesaid address and location;

15 That Affiant is the sole resident stockholder, as well as the
16 owner of 8400 shares of the stock of said corporation of a total
17 outstanding shares of 8700. The owners of said 300 shares being
18 inactive and non-participating stockholders;

19 That Affiant, acting in his capacity as Owner, President and
20 Editor-Publisher of said Lincoln County Record heretofore engaged
21 the services of one LEO A. STEVENS as an employee of said corp-
22 oration to assist affiant and other employees in the weekly pub-
23 lication of the Lincoln County Record newspaper;

24 That Affiant on or about the 6th day of April 1979 determined
25 the services of said Leo A. Stevens were no longer required for
26 the production of said newspaper, terminated said Leo A Stevens
27 from his employment with said corporation;

28 That thereafter said Leo A. Stevens recorded, in the Office
29 of the Lincoln County Recorder, at Pioche, Nevada a document which
30 purported to transfer Affiant's interest in and to the assets of
31 said corporation as well as Affiant's stock in said corporation

6 or deliver unto the said Leo A. Stevens;

7 Further that Affiant has had no such agreement with the said
8 Leo A. Stevens, either orally or written to transfer, presently
9 or in the future, any ownership interest in said corporation or
10 in said Lincoln County Record newspaper unto the said Leo Stevens;

11 That Affiant has no knowledge as to how said Leo A. Stevens
12 came into possession of said false document;

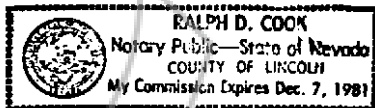
13 Further Affiant sayeth that said Leo A. Stevens is no longer
