THIS INDENTURE, made this 25th day of April, 1979, by and between RUBY . LISTER, County Treasurer and Ex-officio Tax Receiver of Lincoln County, Nevada, as Grantor,

AND

RUBY LISTER, County Treasurer of Lincoln County, Nevada, as Trustee, in Trust for the use and benefit of the State of Nevada, and the County of Lincoln, and any officers having fees due them, as Grantee,

WITNESSETH:

THAT WHEREAS, the said RUBY LISTER, is the duly elected, qualified and acting Treasurer and Ex-officio Tax Receiver of Lincoln County, Nevada, and as such, is custodian of the records of said Treasurer's Office, and

WHEREAS, on the 17th day of May, 1976, the County Auditor of said Lincoln County delivered to Ruby Lister, County Treasurer and Ex-officio Tax Receiver of Lincoln County, the official Assessment Roll of the Said county of Lincoln for the Fiscal Year 1975-1976, with his certificate attached thereto, upon receipt of which notice was duly given by Ruby Lister, Ex-officio Tax Receiver, in full compliance with the Revised Statutes of Nevada 361.480, which would be delinquent after the first Monday in March, 1977, the said Ruby Lister, on April 25, 1977, as Ex-officio Tax Receiver entered upon the assessment roll a statement that she had made a levy upon all property therein assessed upon which the taxes for the Fiscal Year 1975-1976 had not been half and marked the word "DELINODENT" on said assessment roll opposite the name of the person or description of the property liable for such taxes, and thereupon prepared a delinquent list in which it was specified that the taxes against the persons named in this "DEED", as owners of the following described property:

That thereafter, immediately after the first Monday in March, 1977, Ruby Lister, as Ex-Officio Tax Receiver, gave notice by Publication in the manner and form prescribed by Nevada Revised Statutes 361.565, stating in said notice, the name of the owner, the description of the property, the amount of the taxes due on the property and the penalties, costs, be not paid by the said owner, or taxpayer or his or her successor in interest, the said Tax Receiver would, on the fourth Monday in April, 1977, at 1:30 o'clock in the afternoon of said day, issue to the County Treasurer, as Trustee for the State of Novada and County of Lincoln, a certificate authorizing him to hold said property, subject to redemption within Two (2) years after date thereof, by Dayment of said taxes and accruing taxes, penalties, and costs, together with interest at the rate of Ten per cent (10%) per annum, from date due until paid, as provided by law, and that such redemption may be made in accordance with the provisions of the Civil Act of this State in regard to real property sold under execution.

AND WHPREAS, payments of said taxes, penalties and costs not having been made before the fourth Monday in April, 1977, said Ruby Lister, as Expofficio Tax Receiver, did on said date, pursuant to said notice, and at the time so noticed, make out a Certificate authorizing Ruby Lister, County Treasurer, or her successor, as Trustee for the State and County, to hold the property described therein for the period of Two (2) years after the date thereof, unless sooner redeemed.

AND WHEREAS, the time for redemption allowed by law has expired, and no redemption of said property has been made within said time, or at any time prior to date of this "INDENTURE".

NOW, THEREFORE THIS INDENTURE WITNESSETH:

That the said RUBY LISTER, Ex-officio Tax Receiver and Grantor, as aforesaid, by virtue of the premises and strict compliance with all statutes in such cases made and provided, and for the consideration therein stated does hereby, grant, bargain, sell and convey and confirm to the said Ruby Lister, County Treasurer of Lincoln County, and Grantee, as aforesaid, and to her successors forever, in trust, for the use and benefit of the State of Nevada, and the County of Lincoln, and any officers having fees due them in connection herewith, all property and improvements hereinafter described.

TOGETHER, with all the singular the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining. Tax Deed 1977-1978 Page Three

TO HAVE AND TO HOLD ALL and singular the hereinbefore described premises, together with the appurtenances, unto the said Grantee, and to her successor in office forever.
