DECREE OF DIVORCE

14 This cause came on regularly this day for trial; Plaintiff  
15 appeared in person and by and through her attorney; JOHN S.  
16 MCGIMSEY; Defendant was not present, but heretofore filed herein,  
17 in proper person, his duly acknowledged Answer, authorizing this  
18 Court to hear this cause without further delay or notice; the  
19 Court, having heard the testimony having examined the proofs of-  
20 fered and being fully advised in the premises, finds the facts  
21 as follows:

- 22 1. Plaintiff is a resident of the State of Nevada and for
- 23 a period of more than six weeks immediately preceding the com-
- 24 mencement of this action has been and is now a bonafide and actual
- 25 resident of Lincoln County, Nevada, having been corporally present
- 26 therein for said period of time.
- 27 2. Plaintiff and Defendant intermarried on or about December
- 28 21, 1946, in Las Vegas, Clark County, Nevada, and ever since have
- 29 been and now are wife and husband.
- 30 3. That no children have been born the issue of said marr-
- 31 iage.
- 32 4. That there are no community debts.
- 5. That the parties have the following community property

1 which should be distributed to the Defendant:

2 A. Lot containing a Colombia Mobile Home together with share  
3 of Panaca Irrigation Co. Certificate No. 495 more particularly  
4 described as:

5 The South Half of the Northeast Quarter (S/2 NE/4) of Lot  
6 Two (2), Block Twenty-eight (28) in the Town of Panaca,  
County of Lincoln, State of Nevada, together with one-half  
(1/2) share of water in Panaca Irrigation Company.

7 The Northwest Quarter (NW1/4) of Lot Two (2) in Block Twenty-  
8 eight (28) in the Town of Panaca, County of Lincoln, State  
9 of Nevada, together with any and all improvements situate  
thereon.

10 The North Half of the Northeast Quarter (N/2 NW/4) of Lot  
11 Two (2), Block Twenty-eight (28) in the Town of Panaca,  
County of Lincoln, State of Nevada, together with any and  
12 all improvements situate thereon.

13 B. 1968 International Travel All motor vehicle.

14 C. Montgomery Ward fiber glass boat.

15 D. Ideal camper trailer.

16 6. That the 1976 Plymouth automobile should be distributed  
17 to the Plaintiff.

18 7. That the parties should share and share alike their  
19 savings and silver dollar collection.

20 8. That the following described real property should be sold  
21 the Plaintiff to receive \$17,000.00 from said sale, with the re-  
22 mainder of the proceeds of the sale to be shared equally:

23 South One Half (1/2) of the North One Half (1/2) of the East  
24 One Half (1/2) of Lot Five (5), Block Twelve (12) Arrowhead  
Acre Tract, as shown on maps thereof on file in Book 1 of  
25 Plats, Page 62, in the Office of the County Recorder of  
Clark County, Nevada.

26 Subject To: Rights of way, Reservations, Restrictions, and  
27 conditions of record.

28 9. That the parties hereto are incompatible in their marr-  
29 ied life.

30 As conclusions of law from the foregoing facts the Court finds  
31 that Plaintiff is entitled to a judgment dissolving the bonds of  
32 matrimony heretofore and now existing between Plaintiff and Def-

1 endant be, and the same are hereby, wholly dissolved and held for  
2 naught and said Plaintiff is hereby awarded an absolute decree of  
3 divorce from Defendant upon the ground of Incompatibility and  
4 each of the respective parties is hereby restored to the status  
5 of a single and unmarried person.

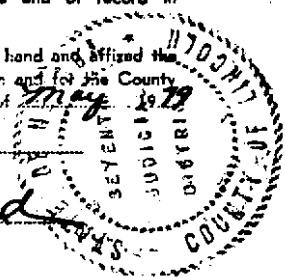
