D. R. ROLFE, being first duly sworn, deposes and says that he is a citizen of the United States of America, over the age of twenty-one (21) years, resides in the City of Alamo, County of Lincoln, State of Nevada, and has personal knowledge of the facts stated herein.

That upon various dates and during various periods of time between the 1st day of September 1978 and the 31st day of August 1979 not less than SIX THOUSAND NINE HUNDRED DOLLARS (\$6900) worth of work was done and performed for the benefit of the following described unpatented mining claims in Lincoln County, State of Nevada:

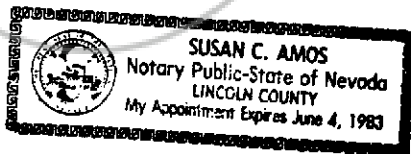
In addition to the above normal work related to mining, the tailings dam was extended both laterally and vertically, one and a half miles of mine road was oiled and all of the lode claims and many of the mill site claims were surveyed and mapped by aerial photography.

That said work was applicable to the annual assessment work requirement for the assessment year beginning noon, September 1, 1978, and ending at noon on September 1, 1979.
