14 This cause came on regularly this day for trial; Plaintiff
15 appeared in person and by and through her attorney, JOHN S.
16 MCGIMSEY; Defendant did not appear in person nor by counsel, his
17 default having been heretofore duly entered for his failure to
18 appear and answer Plaintiff's Complaint within the time allowed
19 by law; the Court, having heard the testimony, having examined
20 the proofs offered and being fully advised in the premises, finds
21 the facts as follows:

22 1. Plaintiff is a resident of the State of Nevada and for a
23 period of more than six weeks immediately preceding the commence-
24 ment of this action has been and is now a bonafide and actual
25 resident of Lincoln County, Nevada, having been corporally pre-
26 sent therein for said period of time.

27 2. Plaintiff and Defendant intermarried on or about October
28 2, 1954 in Hazlet, New Jersey, and ever since have been and now
29 are husband and wife.

30 3. That four of the children that have been born the issue
31 of said marriage are under the age of 18; to-wit: DANIEL G. WALL-
32 ING, son, born January 1, 1963; REBECCA A. WALLING, daughter,

1 born June 20, 1966; RONALD D. WALLING, son, born July 15, 1969;
2 and BONNIE J. WALLING, daughter, born November 24, 1977; that
3 Plaintiff is a fit and proper person to have the care, custody
4 and control of said children; that Defendant should pay \$75.00
5 per month per child, for the care, support, maintenance and edu-
6 cation of said children, reserving to him reasonable rights of
7 visitation so long as he is current in the payment of child supp-
8 ort.

9 4. That the following community property be distributed to
10 the Plaintiff and the obligation thereon be assumed by the Defen-
11 dant:

12 Lots 1, 2, 3, 4, 50, 51 and the adjoining 20.7 feet of Lot
13 52, all in Block 32, in the town of Pioche, Lincoln County,
Nevada.

14 5. That the parties hereto are incompatible in their married
15 life.

16 As conclusions of law from the foregoing facts the Court find
17 that Plaintiff is entitled to a judgment dissolving the bonds of
18 matrimony heretofore and now existing between Plaintiff and Def-
19 endant upon the ground of Incompatibility. Judgment will be en-
20 tered accordingly.

21 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the bonds of
22 matrimony now and heretofore existing between Plaintiff and Defen-
23 dant be, and the same is hereby, wholly dissolved and held for
24 naught and said Plaintiff is hereby awarded an absolute decree of
25 divorce from Defendant upon the ground of Incompatibility and each
26 of the respective parties is hereby restored to the status of a
27 single and unmarried person.

28 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the care,
29 custody and control of the four minor children, DANIEL C. WALLING,
30 REBECCA A. WALLING, RONALD D. WALLING, and BONNIE J. WALLING, are
31 hereby awarded to Plaintiff. Defendant is ordered to pay \$75.00
32 per month per child as and for child support beginning with the

1 month of September 1, 1979 and continuing each and every calendar month thereafter until each child reaches the age of maturity, marries or is otherwise emancipated. Reasonable rights of visitation are reserved to Defendant so long as he is current in the payment of child support.

6 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Plaintiff be awarded the community property described as: Lots 1, 2, 3, 4, 50, 51 and the adjoining 20.7 feet of Lot 52, all in Block 32, in the town of Pioche, Lincoln County, Nevada, and that Defendant assume the financial obligation thereon.
