

# Certificate of Location of Lode Mining Claim

TO ALL WHOM IT MAY CONCERN:

The claim is 1500 feet long and 600 feet wide, and 25 feet is claimed in a W direction and 475 feet in a E direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 200 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the E to the W.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by ALUMINUM 4 X 25 Poly SUTURE TIE (Describe method of marking, such as "scrubbing the wood")

The description of each corner is as follows (describe the corner(s), such as "4x4 wooden post"):

- Corner No. 1 is a NW COR MARKED NW COR FRSD # 26
- Corner No. 2 is a W Side Center W.S.C.
- Corner No. 3 is a NE COR NE COR
- Corner No. 4 is a SE COR SE COR
- Corner No. 5 is a S Side Center S.S.C.
- Corner No. 6 is a SW COR SW COR

The monumentation and marking of the corners was completed by the 10 day of July, 1979. (Must be within 20 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Lincoln County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
