

Certificate of Location of Lode Mining Claim

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies (certify) that he (she, they) has (have) located the Lode Mining Claim Section 33, Township 9 N, Range 65 E in the 25th Mining District, in Lincoln County, in the State of Nevada, on the 7 day of July, 1979.

The claim is 1500 feet long and 600 feet wide, and 25 feet is claimed in a E direction and 1475 feet in a W direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the E to the W.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by MARKING 4" X 5" Poly SINKER PIPE (Describe method of marking, such as "scriling the wood")

The description of each corner is as follows (describe the corner(s), such as "4x4 wooden post"):

- Corner No. 1 is a NW COR. MARKED NW COR FRED # 39
- Corner No. 2 is a N Side Center " NSC "
- Corner No. 3 is a NE COR " NE COR "
- Corner No. 4 is a SE COR " SE COR "
- Corner No. 5 is a S. Side Center " SSC "
- Corner No. 6 is a SW COR " SW COR "

The monumentation and marking of the corners was completed by the 10 day of July, 1979. (Must be within 20 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Lincoln County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
