

# Certificate of Location of Lode Mining Claim

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies (certify) that he (she, they) has (have) located the Fred #4 Lode Mining Claim in Section 33, Township 9N, Range 65E in the Patterson Mining District, in Lincoln County, in the State of Nevada, on the 7 day of July, 1979.

The claim is 1500 feet long and 600 feet wide, and 25 feet is claimed in a W direction and 1475 feet in a E direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the E to the W.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by MARKING 4" x 5" POLY-SEWER PIPE

- Corner No. 6 is a SW COR " SW COR "

The monumentation and marking of the corners was completed by the 10 day of July, 1979.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Lincoln County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
