The Wonder No. 9 Mining Lode Claim

hereby certifies that in compliance with the Mining Act of Congress, approved May 10, 1872, and all subsequent Acts and with the Nevada Revised Statutes and with local customs, laws, and regulations, did, on the 1st day of June 1929 locate and claim by right of discovery a lode mining claim named the Wonder No. 9 situate in the Comet Mining District, Lincoln County, Nevada.

The locator(s) claims 1,500 linear feet along the course of the mineral bearing lode or vein, extending from the location monument 100 feet in a East direction and 1,400 feet in a West direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the lode or vein, as near as may be is East and West.

The location work consisted of the making of maps as provided in NRS 517.040.

This claim is more particularly described by reference to some natural object or permanent monument as follows: The NE corner, marked "N.E. COR.", is approximately 2,780 feet North and 490 feet East from: SW Corner of Section 4, Township 1 S, Range 66E, M.D.B.M.

Thence: 600 feet South to the SE Corner, marked "SE COR."
750 feet West to the South Side Center, marked "SSC"
750 feet West to the SW Corner, marked "SW COR."
600 feet North to the NW Corner, marked "NW COR."
750 feet East to the North Side Center, marked "NSC"
750 feet East to the NE Corner, the place of beginning

Each of the above-described monuments is a post at least 4 inches in diameter and 4 1/2 feet in length set approximately one foot in the ground. All claim corners and side centers were erected on or before 10-20-79 (within 30 days of posting location notice).

The following claims adjoin this claim and the respective side and/or end lines of this claim are common, in whole or in part, with the respective side and/or end lines of such adjoining claims:

Snow No. 21 claim on the North, Wonder claim on the East

Wonder No. 1 & 3 claim on the South, Gigolo No. 2 claim on the West

Said claim is located in the NW 1/4 & SW 1/4 of Section 4 and the NE 1/4 & SE 1/4 of Section 5, T 1 S, R 66E, Mount Diablo principal Meridian.
