

AMENDED LOCATION CERTIFICATE

KNOW ALL MEN BY THESE PRESENTS, THAT DEE BURGESS and RICHARD BURGESS

citizens of the United States, having complied with all requirements of all the laws of the United States and the State of Nevada relating to mining claims, and with all local laws, customs, rules and regulations of the Eagle Valley mining district, hereby make and file this amended location of the Lookout No. 2 lode, claiming by right of discovery and location, primal appropriation and possession, 1500 feet linear and horizontal measurement on this vein or lode of mineral in place, along the course of said vein, with all the dips, variations, and angles, together with 300 feet in width on each side of the middle of the vein, at the surface, and all veins, lodes, mineral deposits, ledges and surface ground with the lines of said claim, approximately 750 feet running North and 750 feet running South from the discovery monument. Said Discovery monument is situated:

Approximately 600 feet Southeast from the Discovery monument of Lookout No. 1 which is tied to the Northwest corner of Section 8, Township 1 North, Range 71 East. The Northwest side line of this claim joins the Southeast side line of Lookout No. 1 situated in Lincoln County, Nevada.

All corners and side centers of this claim have been erected and properly /marked.
