CERTIFICATE OF LOCATION

THIS IS TO CERTIFY that the M. D. M. NO. 27 lode mining claim

was located by:

on the 4 day of DECEMBER, 1979, situated in the PATTERSON Mining District, LINCOLN County, State of NEVADA, in Section 19, Township 9 EAST N., Range 65 NORTH E

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1480 feet from the location monument in a EAST direction, and 20 feet in a WEST direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4/4 POST 5 feet high, inscribed "NW Corner of the M. D. M. NO. 27 Claim;" the southwest corner is marked by a POST 5 feet high, inscribed "SW Corner of the M. D. M. NO. 27 Claim;" the southeast corner is marked by a 4/4 POST 5 feet high, inscribed "SE Corner of the M. D. M. NO. 27 Claim;" the northeast corner is marked by a 4/4 POST 5 feet high, inscribed "NE Corner of the M. D. M. NO. 27 Claim." There is also a 5 ft. POST at the center of each side line.

The monumentation and marking of the corners was completed by the 1 day of DEC, 1979 (must be within 20 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the LINCOLN County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
