

ASSIGNMENT

For value received, the undersigned, BRADSHAW, INC., Assignor, hereby grants, assigns, and transfers to JAMES B. TENNILLE and GEORGE R. TENNILLE, Assignee, the range rights including cooperative agreements and ranch improvement permits, and the water rights, which are described in Exhibit "A" attached hereto and made a part hereof.

Assignor expressly reserves all water rights of Assignor in the waters of the Meadow Valley Wash Creek, and, in addition, Assignor expressly reserves the right to fence all of its privately owned lands in the Meadow Valley Wash at Elgin, Nevada.

Said Assignor has informed Assignee that the range rights herewith assigned are presently being readjudicated by the United States Department of the Interior, Bureau of Land Management, and upon final adjudication the grazing privileges hereby assigned may be reduced.

Application, Permit 10062, Certificate 3404, being a right to the waters of Mud Springs for stock watering purposes in the Southwest Quarter of the Northwest Quarter of Section 33, Township 6 South, Range 67 East, Mount Diablo Base and Meridian.
