CERTIFICATE  
AMENDED NOTICE OF LOCATION  
LODE MINING CLAIM

The undersigned, owners of the COT # 135 Lode Mining Claim originally located on March 16, 1979 and recorded in Book 29, Page 415 of Lincoln County, Nevada hereby locate and claim in compliance with all federal, state and local laws and customs applicable thereto the following described valuable lode or vein mineral deposit:

1. The name of this claim is COT # 135 (Amended) lode mining claim situated in the State Line Mining District, Lincoln County, Nevada in the NE 1/4 SE 1/4 of section 7 T 2 N, R 71 E, M.D.B. & M.
2. The location monument is situated 750 feet from the north end line and 750 feet from the south end line, in the center of the claim.
3. The locators claim 750 feet in a north direction and 750 feet in a south direction along the course of the vein or lode each way from the location monument and 300 feet to each side of the center of the vein or lode, together with all dips, spurs, angles and variations. The general course of the lode deposit and premises is from the north to the south.
4. The boundaries of this claim are described as follows:  
Beginning at the Northeast corner (corner No. 1) of this claim; thence south 1500 feet; thence west 600 feet; thence north 1500 feet; thence east 600 feet to the point of beginning. The Northeast corner (corner No. 1) of this claim is a 4" diameter white plastic pipe or blazed tree from which the Northeast corner of section 17, T 2N, R 71E, M.D.B. & M. bears: SOUTH 2850 feet, and East 5500 feet. All corners and location monument are 4" diameter white plastic pipe or blazed trees in conformance with Nevada law.

This Amended Notice of Location is made for the purpose of appropriating under the applicable Mining Laws all ground and mineral deposits within the boundaries described above, of more definitely describing the locality and boundaries of said claim, and of in particular correcting two errors in the original notice of location: 1. The general course of the lode deposit and premises has been changed to North - South, and 2. The dimensions of the claim have been changed to 600 feet by 1500 feet, and is made without waiving any rights acquired under and by virtue of said original location. If said original location is at the time of this amendment ineffective for any reason as to any ground described above, this Amended Notice of Location shall be an original Notice of Location.
