NOTICE AND CERTIFICATE OF
AMENDED LOCATION OF MILL SITE
BY OWNERS OF PLACER CLAIM

NOTICE IS HEREBY GIVEN that the undersigned, locator, MARBLEHEAD LIME COMPANY, whose post office address is 300 West Washington Street, Chicago, Illinois 60606, proprietor of the Dorothy Placer Claims No. 1 thru No. 52, all in the mining district named below, did on the 24th day of March, 1980, amend, locate and claim, and does hereby amend, locate and claim by right of location and this Notice and Certificate of Amended Location, and in compliance with the mining laws of the United States and the State of Nevada, and the local customs and rules of the district in which the claim is located, five (5) acres of non-mineral ground needed by the proprietor of said Placer Claims for mining, milling, processing, beneficiation, and other operations connected with such claims, and used and occupied by the undersigned for such purposes. Thence, 466.69' westerly to the southwest corner;

Thence, 466.69' northerly to the northwest corner;

Thence, 466.69' easterly to the northeast corner, the Point of Beginning,

The Location Monument stands at the northeast corner of this Mill Site Claim.
