

# Certificate of Location of Lode Mining Claim

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies (certify) that he (she, they) has (have) located the 700' x 150' Lode Mining Claim in Section 22 Township 14N Range 61E in the 27 Mining District, in Lincoln County, in the State of Nevada, on the 31 day of March, 1980.

The claim is 1500 feet long and 200 feet wide, and 1500 feet is claimed in a 270° 20' direction and 150 feet in a 270° 20' direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 200 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the W 27° 20' to the E 27° 20'.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by X ALBERT G. COTTINO

The description of each corner is as follows (describe the corner(s), such as "1x4 wooden post"):

- Corner No. 1 is a 4x4 wooden post, 50 ft on corner as SW corner level of claim
- Corner No. 2 is a 4x4 post 200' corner side
- Corner No. 3 is a 4x4 post NE corner
- Corner No. 4 is a 4x4 post NW corner
- Corner No. 5 is a 4x4 post 200' corner side
- Corner No. 6 is a 4x4 post SW corner

The monumentation and marking of the corners was completed by the 31 day of March, 1980.

The location work consisted of making a claim map as provided in NRS 517.010. Two copies of this claim map have been filed with the Lincoln County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
