## Certificate of Location of Lode Mining Claim

TO ALL WHOM IT MAY CONCERN:

The claim is 150' 0" feet long and 60' 0" feet wide, and 650' feet is claimed in a S 10 E 20' W direction and 850' feet in N 45 E 30' W direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 30' 0" feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the S 45 E 30' to the E 45 S 30'.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by a

The description of each corner is as follows (describe the corner(s), such as "IV wooden post"):

Corner No. 1 is a 4x4 post 5 1/2 inches square at NE corner.

Corner No. 2 is a 4x4 post 4 1/2 inches square at SW corner.

Corner No. 3 is a 4x4 post 4 1/2 inches square at SE corner.

Corner No. 4 is a 4x4 post 4 1/2 inches square at NW corner.

Corner No. 5 is a 4x4 post 4 1/2 inches square at SE side.

Corner No. 6 is a 4x4 post 4 1/2 inches square at NW side.

The monumentation and marking of the corners was completed by the 1/2 day of March, 1980.  
(Must be within 20 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.010. Two copies of this claim map have been filed with the County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
