

Certificate of Location of Lode Mining Claim

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies (certify) that he (she, they) has (have) located the *Albert Cottino* Lode Mining Claim in Section *22*, Township *1 N*, Range *6 E* in the *Ely* Mining District, in *Lincoln* County, in the State of Nevada, on the *2* day of *March*, 1980.

The claim is *1500* feet long and *600* feet wide, and *650* feet is claimed in a *S10° 30' W* direction and *850* feet in a *N10° 30' E* direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with *300* feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the *SE 1/4* to the *E 1/4*.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by *ALUMINUM NAILS*.

The description of each corner is as follows (describe the corner(s), such as "1x4 wooden post"):

- Corner No. 1 is a *4x4 post SE corner same as NW corner*
- Corner No. 2 is a *4x4 post E side*
- Corner No. 3 is a *4x4 post NE corner*
- Corner No. 4 is a *4x4 post NW corner*
- Corner No. 5 is a *4x4 post West center side*
- Corner No. 6 is a *4x4 post SW corner same as NE corner*

The monumentation and marking of the corners was completed by the *2* day of *March*, 1980.

The location work consisted of making a claim map as provided in NRS 517.010. Two copies of this claim map have been filed with the *Lincoln* County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
