

MEMORANDUM OF GRUBSTAKE AGREEMENT

NOTICE IS HEREBY GIVEN that LYLE F. CAMPBELL, a single man ("Campbell"), as one party, and AMSELCO MINERALS INC., a Delaware corporation, and OCCIDENTAL MINERALS CORPORATION, a Delaware corporation ("Amsel/Oxymin"), collectively as the other party, have entered into a Grubstake Agreement with an effective date of April 1, 1979 ("Grubstake Agreement"). Under the terms of the Grubstake Agreement, Campbell, in consideration of the grubstake which Amsel/Oxymin has agreed to provide, has agreed to prospect for valuable mineral deposits (except oil, gas, coal, shale oil, geothermal resources, phosphate rock and sulphur) in those portions of the States of California, Nevada, Idaho, Utah, and Oregon which are shown on Exhibit A which is attached hereto and by this reference is made a part hereof (hereinafter "Prospecting Area").

Sections 2.1 and 3.1 of the Grubstake Agreement provide as follows:

"2.1 Except as otherwise herein provided, this Agreement shall be for a term of six (6) months beginning April 1, 1979, and ending September 30, 1979, during which Campbell shall prospect for six (6) calendar months. If at any time or times prior to the end of the term hereof Campbell shall be forced to suspend prospecting due to illness, accident or any other factor or circumstance beyond his reasonable control, Campbell shall promptly give Amsel/Oxymin written notice thereof setting forth the date such suspension commenced. At such time as Campbell is able to resume prospecting hereunder he may do so upon giving

written notice of such resumption to Amsel/Oxymin setting forth the date of such resumption; provided, however, that in all events this Agreement shall terminate on September 30, 1979, even if six (6) months of prospecting have not then been completed hereunder."

"3.1 During the term hereof Campbell shall, diligently and in good faith, prospect for Minerals in the Prospecting Area for the sole and exclusive account of Amsel/Oxymin."

Under the terms of the Grubstake Agreement, Campbell has agreed to present for acceptance by Amsel/Oxymin any Mineral Prospects located by him and, if Amsel/Oxymin shall accept the same, to enter into Mineral Lease and Option to Purchase Agreements, pursuant to which Campbell would grant to Amsel/Oxymin leases of the mining claims representing the Mineral Prospects for a period of twenty (20) years and so long thereafter as there is production of one or more mineral products from the Mineral Prospect, together with the sole, exclusive and irrevocable option to purchase the Mineral Prospect during the same period.

In consideration of the covenants and obligations contained in the Grubstake Agreement, Campbell and Amsel/Oxymin hereby ratify and confirm all of the agreements, covenants and conditions contained in said Grubstake Agreement and incorporate the same herein by this reference.





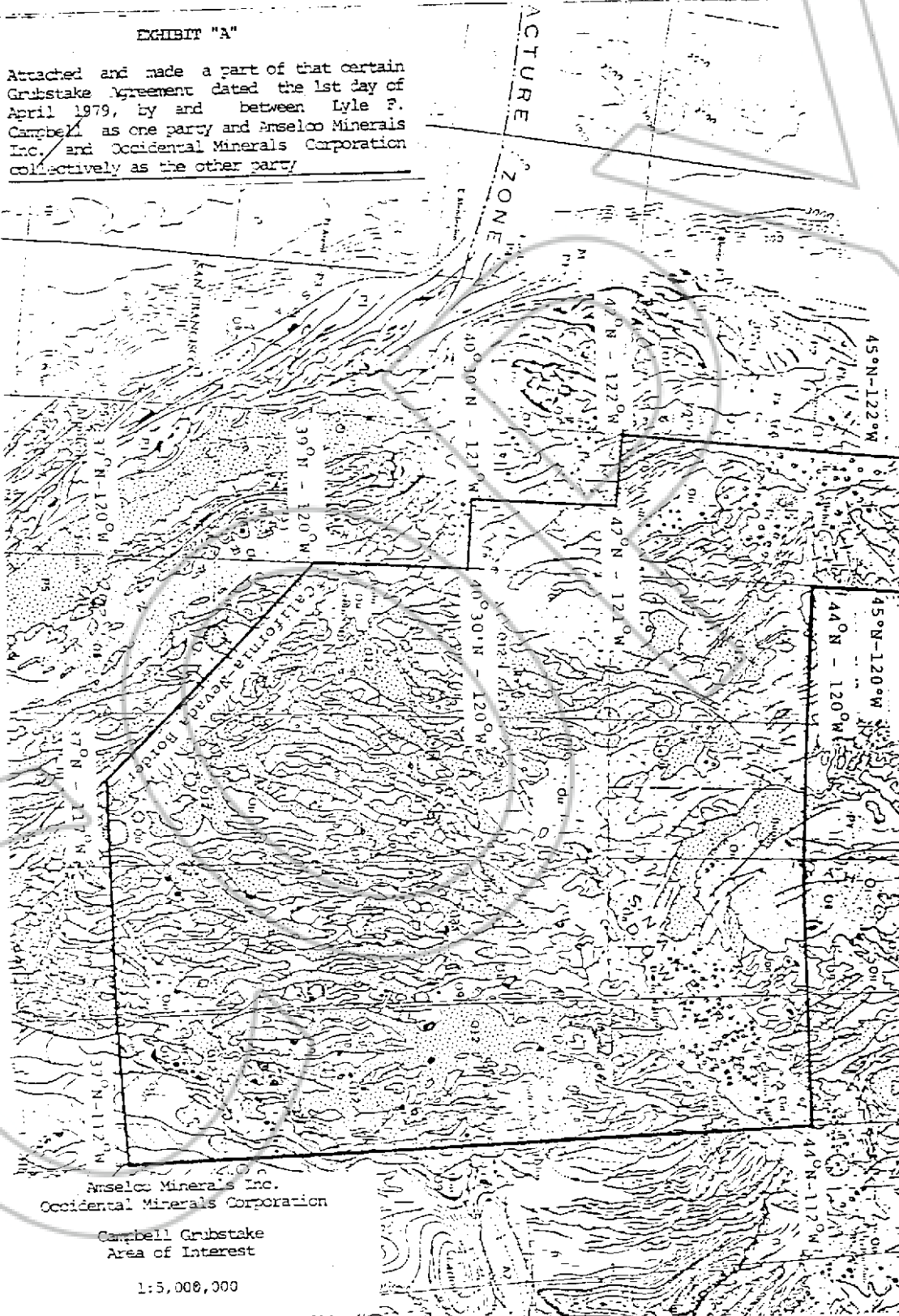
