

Certificate of Location of Lode Mining Claim

TO ALL WHOM IT MAY CONCERN:

This claim is located in portions of the SE/4 and SW/4 of section 3, T3N, R65E, Mount Diablo meridian.

The claim is 1500 feet long and 600 feet wide, and 50 feet is claimed in a Easterly direction and 1450 feet in a Westerly direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the East to the West.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by an embossed metal tag.

The description of each corner is as follows (describe the corner(s), such as "4x4 wooden post"):

- Corner No. 1 is a 6" diameter tree, topped and squared.
- Corner No. 2 is a 4" X 4" wooden post
- Corner No. 3 is a 4" X 4" wooden post
- Corner No. 4 is a 4" X 4" wooden post
- Corner No. 5 is a 4" X 4" wooden post
- Corner No. 6 is a 4" X 4" wooden post

The monumentation and marking of the corners was completed by the 20th day of April, 1980.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Lincoln County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
