17 The above-entitled matter, having come before this Court
18 pursuant to Plaintiffs' timely and duly noticed Notice of
19 Application for Default Judgment, and this Court having reviewed
20 all the papers and pleadings on file including the Affidavits of
21 Plaintiffs herein and it appearing that Defendants MEDALLION
22 CORPORATION and DAVID COMPTON have failed to file an answer or
23 other response in the above-entitled action although having been
24 duly served and their default having been entered by the Clerk
25 of this Court and there being no opposition to said Notice of
26 Application for Default Judgment;

27 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that
28 Plaintiffs are entitled to judgment from Defendants MEDALLION
29 CORPORATION and DAVID COMPTON, as follows:

30 1. That Defendants MEDALLION CORPORATION and DAVID
31 COMPTON shall pay to Plaintiffs PHILIP COFFIN and ANN COFFIN the
32 sum of FIVE THOUSAND (\$5,000.00) DOLLARS plus interest at the

1 rate of 12% per annum from November 6, 1978 until the principal
2 amount of FIVE THOUSAND (\$5,000.00) DOLLARS is paid in full;

3 2. That Defendants MEDALLION CORPORATION and DAVID
4 COMPTON shall pay to Plaintiffs CLARENCE PIGGOTT and BEVERLY
5 PIGGOTT the sum of FIVE THOUSAND (\$5,000.00) DOLLARS plus
6 interest at the rate of 12% per annum from November 7, 1978
7 until the principal amount of FIVE THOUSAND (\$5,000.00) DOLLARS
8 is paid in full;

9 3. That Defendants MEDALLION CORPORATION and DAVID
10 COMPTON shall pay to Plaintiff ANN MARIE ANDOLINA the sum of
11 FIVE THOUSAND (\$5,000.00) DOLLARS plus interest at the rate of
12 12% per annum from November 7, 1978 until the principal amount
13 of FIVE THOUSAND (\$5,000.00) DOLLARS is paid in full;

14 4. That Defendants MEDALLION CORPORATION and DAVID
15 COMPTON shall pay to STEPHEN R. MINAGIL, ESQ., the sum of
16 \$1,000.00 as and for a reasonable attorney's fee; and

17 5. That Defendants MEDALLION CORPORATION and DAVID
18 COMPTON shall pay to the Plaintiffs the sum of \$276.00 for
19 costs of suit incurred herein.
