29 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the  
30 Plaintiff, MELVIN M. MELTON, have and recover from the Defendants,  
31 and each of them judgment in the sum of TWENTY SIX THOUSAND NINE  
32 HUNDRED EIGHTY SEVEN AND 63/100 DOLLARS (\$26,987.63) plus interest

2 on TWENTY THREE THOUSAND NINE HUNDRED EIGHTEEN AND 32/100 DOLLARS  
3 (\$23,918.32) of said amount until paid in full and with additional  
4 interest at the rate of eight (8%) per cent per annum from September  
5 7, 1979 on the remaining THREE THOUSAND SIXTY NINE AND 31/100  
6 DOLLARS (\$3,069.31) of said amount until paid in full, amounting to  
7 SEVEN AND 23/100 DOLLARS (\$7.23) of total interest per day from  
8 September 7, 1979 and totaling as interest through July 3, 1980,  
9 TWO THOUSAND ONE HUNDRED SEVENTY SIX AND 23/100 DOLLARS (\$2,176.23)  
10 plus costs of suit in the sum of NINETY EIGHT DOLLARS (\$98.00), and  
11 plus reasonable attorney's fees in the sum of \$ 2000.00  
12 for a TOTAL JUDGMENT of \$ 31,261.86 plus judgment int-  
13 erest at the rate of ten (10%) per cent per annum from the date  
14 hereof on TWENTY THREE THOUSAND NINE HUNDRED EIGHTEEN AND 32/100  
15 DOLLARS (\$23,918.32) of said total judgment and additional interest  
16 at the rate of eight (8%) per cent per annum on the remainder of  
17 said total judgment until paid in full.

18 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the  
19 Counterclaim of the Defendants EDWARD R. STEIN and NONA STEIN be,  
20 and the same hereby is, dismissed with prejudice.
