The claim is 1500 feet long and 600 feet wide, and 5 feet is claimed in a easterly direction and 1495 feet in a westerly direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the east to the west.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by scribing an aluminium tag stapled on the post

- Corner No. 5 is a 4x4 wood post side center on common boundary of Karen 10 & 11
- Corner No. 6 is a 4x4 wood post on SW corner of claim

The monumentation and marking of the corners was completed by the 7th day of June, 1980.
