

GENERAL RELEASE

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, on March 15, 1964, SALT LAKE-PIOCHE MINING COMPANY, a Utah corporation, as Lessor, and INDEX-DALEY MINES COMPANY, an Idaho corporation, as Lessee, entered into a Mining Lease and Option covering certain patented and unpatented mining claims located in the Ely Mining District, Lincoln County, Nevada, which Mining Lease and Option was recorded on March 31, 1964, in Book Q of Misc. at page 101 of Lincoln County, Nevada, records;

WHEREAS, INDEX-DALEY MINES COMPANY assigned all of its right, title and interest in and to the Mining Lease and Option to CHARLES E. BLEAK and DONALD B. WHEREAS, CHARLES E. BLEAK assigned all of his right, title and interest in and to the Assignment of Interest to DONALD B. POTTS by Assignment of Interest dated March 20, 1967, and recorded on May 16, 1967, in Book Q of Misc. at page 404 of Lincoln County, Nevada, records;

NOW, THEREFORE, in consideration of the sum of SEVEN THOUSAND FIVE HUNDRED DOLLARS (\$7,500.00) in hand paid to INDEX-DALEY MINES COMPANY by DONALD B. POTTS, the receipt whereof is hereby acknowledged, the said INDEX-DALEY MINES COMPANY does by these presents release and discharge DONALD B. POTTS, his heirs and assigns, of and from, all, and all manner of actions, and causes of actions, claims and demands whatsoever in law, or in equity, which the said

INDEX-DALEY MINES COMPANY ever had or now have or could enforce against the said DONALD B. POTTS by reason of that certain Assignment of Mining Lease executed by INDEX-DALEY MINES COMPANY to DONALD B. POTTS, et al., and to which reference is hereinabove made.

IN WITNESS WHEREOF, INDEX-DALEY MINES COMPANY has caused to be executed this Release on the 31st day of July, 1980.
