CERTIFICATE OF LOCATION

THIS IS TO CERTIFY that the TEMPER # 27 lode mining claim

Said claim is located in the NE/4 of Sec.       ,  
the SE/4 of Sec. 2, Twp. 4 South, Range 56 East  
NW/4 of Sec.         
SW/4 of Sec.       

To tie this claim to the Public Survey, begin at the N. W. corner of Section  
14, Township 4 South, Range 56 East, Mount Diablo meridian, thence  
6600' North and 1500' East

to the northeast corner of this claim.

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge,  
lode or vein, extending 1490 feet from the location monument in a Easterly direction,  
and 10 feet in a Westerly direction, together with 300 feet on each side of  
the center of the ledge for the entire length of the claim.

The northwest corner is marked by a wood post 4"x4"x4 1/2' high, inscribed "NW Corner  
of the TEMPER # 27 Claim;" the southwest corner is marked by a wood post 4"x4"x4 1/2'  
high, inscribed "SW Corner of the TEMPER # 27 Claim;" the southeast corner is marked  
by a wood post 4"x4"x4 1/2' high, inscribed "SE Corner of the TEMPER # 27 Claim;"  
the northeast corner is marked by a wood post 4"x4"x4 1/2' high, inscribed "NE Corner of  
the TEMPER # 27 Claim." There is also a wood post 4"x4"x4 1/2' at the center of each  
side line.

The monumentation and marking of the corners was completed by the 21<sup>st</sup> day of  
August, 1980.

The location work consisted of making a claim map as provided in NRS 517.040. Two  
copies of this claim map have been filed with the Lincoln County Recorder, and the  
\$18.00 lode claim filing fee has been paid to the County Recorder.
