

NOTICE OF LIEN CLAIM

NOTICE IS HEREBY GIVEN:

1. That JIM and SALLY WILKIN, dba JIM WILKIN TRUCKING, claims a mechanic's lien pursuant to the provisions of NRS 108.221, et seq., laws of the State of Nevada, in the amount of \$11,659.19, on the real property and improvements located on a portion of Block 46, (Forty-six), as shown by map thereof on file in Book 31 of Plats, page 156, Office of the Recorder, Lincoln County, Nevada, more commonly known as 507 Main Street, Caliente, Nevada .
