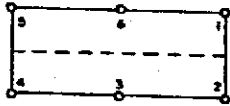
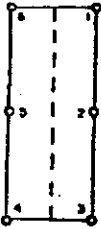

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the DEL 245 Lode Mining Claim on this 15TH day of NOVEMBER, 1980, situated in the UNKNOWN Mining District, LINCOLN County, Nevada.

Said Claim is located in the SE&SW (Quarter), Section(s) 1 Township 6 SOUTH, Range 64 EAST, Mt. Diablo P. M., and more particularly described as follows, to-wit:

Beginning at the Northeast Corner Post Number 1,

- Thence, 600 feet in a SOUTHERLY direction to Post Number 2,
- Thence, 750 feet in a WESTERLY direction to Post Number 3,
- Thence, 750 feet in a WESTERLY direction to Post Number 4,
- Thence, 600 feet in a NORTHERLY direction to Post Number 5,
- Thence, 750 feet in a EASTERLY direction to Post Number 6,
- Thence, 750 feet in a EASTERLY direction to Post Number 1.

the point of beginning, and all posts being 4 1/2" x 4" diameter.

The Claim Monument on which the Notice is posted lies approximately midway between the two sides and is 10 feet from the EAST end and 1490 feet from the WEST end.

To tie this Claim to the Public Survey, begin at the NORTHEAST Corner, Section 25, Township 5 SOUTH, Range 64 EAST, Mt. Diablo P. M., thence bear SOUTH, 14,550 feet and WEST, 1500 feet to the Northeast Corner of this Claim.
