CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the DEL 250 Lode Mining Claim on this 16TH day of NOVEMBER, 1980, situated in the UNKNOWN Mining District, LINCOLN County, Nevada.
