CERTIFICATE OF LOCATION

The undersigned Canyon Resources Corporation, whose address is 2207 Jackson Street, Suite B-101, Golden, Colorado 80401, hereby certifies that it has located the Horse # 15 lode mining claim. The date of location is the 12<sup>th</sup> day of November, 1980.
