Said claim is located in the Protracted NE/4 of Sec. 35, Twp. 3 North, Range 66 East.
SE/4 of Sec. 18
SW/4 of Sec. 18

To tie this claim to the Public Survey, begin at the NE/cor. of Sec. 35 within Township 4 North, Range 65 East, Mount Diablo Meridian, thence

6900' East and 18,000' South

to the northeast corner of this claim.

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 10 feet from the location monument in a Easterly direction, and 1490 feet in a Westerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a wood post 4"x4"x4 1/2' high, inscribed "NW Corner of the SPUR # 156 Claim"; the southwest corner is marked by a wood post 4"x4"x4 1/2' high, inscribed "SW Corner of the SPUR # 156 Claim"; the southeast corner is marked by a wood post 4"x4"x4 1/2' high, inscribed "SE Corner of the SPUR # 156 Claim"; the northeast corner is marked by a wood post 4"x4"x4 1/2' high, inscribed "NE Corner of the SPUR # 156 Claim." There is also a wood post 4"x4"x4 1/2' at the center of each side line.

The monumentation and marking of the corners was completed by the 13th day of December, 1980.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Lincoln County Recorder, and the \$18.00 lode claim filing fee has been paid to the County Recorder.
