

QUITCLAIM DEED

2 THIS INDENTURE made this 24 day of October, 1976, between ELVA  
3 CHRISTMAN, a married woman, of Pioche, Lincoln County, Nevada, as  
4 Grantor, and RAYMOND FREE and ANGE FREE, Husband and wife, of Pioche,  
5 Lincoln County, Nevada, as Grantees:

7 WITNESSETH that the said Grantor in consideration of the sum of Ten  
8 Dollars (\$10.00) lawful money of the United States of America and  
9 other and further valuable consideration, the receipt whereof is  
10 hereby acknowledged, does hereby release and forever QUITCLAIM unto  
11 the said Grantees and to their heirs, successors and assigns forever  
12 all of the right, title and interest of Grantor in and to that cer-  
13 tain real property described as:

14 All of Lots Seventeen (17), Eighteen (18) and Nineteen  
15 (19) in Block Thirty-two (32), as delineated and des-  
16 cribed on the official plat of said Town of Pioche, on  
17 file and of record in the Office of the County Recorder  
18 of Lincoln County, Nevada, together with any and all im-  
19 provements situated thereon, more commonly known as the  
20 "Silver Cafe"; together with all personal property sit-  
21 uate thereon.

22 TOGETHER WITH the tenements, hereditaments and appurtenances there-  
23 unto belonging or in anywise appertaining, and the reversions, re-  
24 mainders, rents, issues and profits thereof.

25 TO HAVE AND TO HOLD all and singular the said premises together with  
26 the appurtenances unto the Grantees and to their heirs, successors  
27 and assigns forever.
