CERTIFICATE OF LOCATION
(Mill Site)

THIS IS TO CERTIFY that the undersigned has located and claimed and by these presents does locate and claim in compliance with the General Mining Laws of May 10, 1872, as amended, and with the laws of the State of Nevada, and with local customs, laws, and regulations, 5 acres of nonmineral land as a mill site for mining or milling purposes.
