CERTIFICATE OF LOCATION OF LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has located the RK# 114 Lode Mining Claim in NV 1/4 SEC 26, Township 1N, Range 58E 59E in the UNKNOWN Mining District, in LINCOLN County, in the State of Nevada, on the 31 day of JAN, 1981.

The claim is 1500 feet long and 600 feet wide, and 10' feet is claimed in a WEST direction and 1490 feet in a EAST direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the EAST to the WEST.
