CERTIFICATE OF LOCATION

The undersigned Canyon Resources Corporation, whose address is 2207 Jackson Street, Suite B-101, Golden, Colorado 80401, hereby certifies that it has located the Horse # 17 lode mining claim. The date of location is the 17<sup>th</sup> day of February, 1981.

The number of linear feet claimed in length along the course of the vein, each way from the point of discovery, is 10 feet in a southerly direction and 1490 feet in a northerly direction, together with 300 feet on each side of the center of the vein. The general course of the lode or vein is north - south.

The Horse # 17 lode mining claim is located in the SW <sup>SE 4</sup> Quarters of Section 22N, T. 2N, R. 69E, M.D.B.&M., Lincoln County, Nevada, and is described by metes and bounds as follows:
